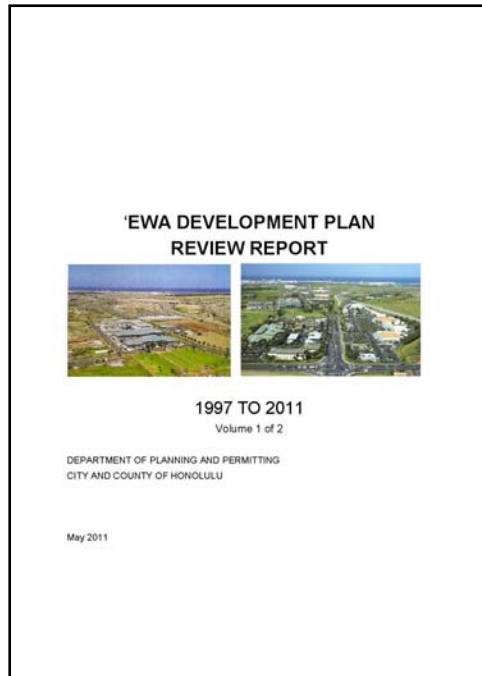


'Ewa Development Plan Review Program

As required by Ordinance No. 97-49 as amended by Ordinance 00-16, the Department of Planning and Permitting has concluded its comprehensive review of the **'Ewa Development Plan** ('Ewa DP).

The results of that review are summarized in a two volume **Review Report** and serve as the basis for proposed revisions to the 'Ewa DP and for suggestions for improving implementation of the Plan vision and policies.

The **Review Report**, the proposed revised **'Ewa Development Plan**, and draft adopting ordinance have been sent to the Planning Commission as the first step in the official process of review and action.
